Buy American Assessment Letter

Date: March 17, 2025

Dear Valued Customer:

We are pleased to provide our assessment under the National School Lunch Act (NSLA, 42 USC 1760(n)) and its regulations ("Buy American"), of the products in the attached table.

Buy American's regulations were changed by a final rule published on April 25, 2024 (with an effective date of July 1, 2024). Important provisions were changed. You can find the changes on USDA's website: [Buy American Provisions Related to the Final Rule - CNP Meal Patterns Consistent with the 2020-25 DGAs | Food and Nutrition Service \(usda.gov\)](https://www.usda.gov/food/nutrition-services/food-and-nutrition-service/food-and-nutrition-service-2024) As you will see in USDA's information, Buy American requires school food authorities in the contiguous United States to purchase, to the maximum extent practicable, domestic commodities or products for the school lunch program. "Domestic commodity or product" is "an agricultural commodity that is produced in the United States" and "a food product that is processed in the United States substantially using agricultural commodities that are produced in the United States." 7 CFR 210.21 (d)(1). "Substantially using agriculture commodities that are produced in the United States means over 51 percent of a food product must consist of agricultural commodities that were grown domestically." 7 CFR 210.21(d)(1)(ii).

Under the new regulations, there are two exceptions to that rule, where school food authorities may purchase non-domestic foods. The school food authority determines that one of the following exceptions applies.

Exception 1- The product is listed on the Federal Acquisitions Regulations (FAR) 25.104 Non-available articles list found at 48 CFR 25.104 and/or is not produced or manufactured in the U.S. in sufficient and reasonably available quantities of a satisfactory quality; or

Exception 2- Competitive bids reveal the cost of a U.S. product is significantly higher than the non-domestic product.

Plus, "non-domestic food purchases (those that do not meet the definition of domestic commodity or product...) must not exceed the following caps by the established deadlines" in the regulation – with different annual limits on the non-domestic purchases as a percentage of a school food authority's total annual commercial food costs. 7 CFR 210.21(d)(5). This summary is just some parts of the new regulation. Please review the actual regulation and other USDA information on USDA's website for Buy American.

As part of the documentation requirements for school food authorities under the new regulations, we are happy to provide you with the attached table, identifying each product as either domestic or non-domestic and, if non-domestic, which of the two above Exceptions applies. We apply Exception 2 when, based on competitive bids for ingredients, the cost of the ingredient (either a single ingredient or multiple) is significantly higher for US sourced ingredients - which would make our product significantly higher than US equivalent products, based on our available information. We encourage you to examine Exception 2 to determine if it applies to your operation. Please note that school authorities will have to determine whether their purchase of non-domestic products is within the applicable annual limit.

Campbell Foodservice Company certifies that, as of the date of this certificate, the products listed on Attachment A, **meet** the requirements of the Buy American: The National School Lunch Act (NSLA, 42 USC 1760(n)) and its regulations.
